

, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 26th day of February, 1963, I found the North east 1/16 corner of Section 3

which was evidenced by the remains of the G.L.O. survey of 1917

The corner was found to be marked by a 1 inch diameter iron post with a brass cap stamped: NE 1/16 S3
1917

Norway pine 10 inch S38-3/4°E 38 links (25.08') (now a 16 inch red pine at record bearing and distance with scribe overgrown).

Norway pine 8 inch S75½°W 14 links (9.24') (now a 15 inch red pine at record bearing and distance with scribe overgrown).

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as the G.L.O. brass cap is in good condition.

from which reference or witness monuments are located in the manner following:

Red pine 11 inch N17½°W 14.0 feet MKD NE 1/16 S 3 BT

Red pine 15 inch S75½°W 9.24 feet MKD BT

Red pine 16 inch S38-3/4°E 25.08 feet MKD BT

Steel sign post 72 inches long, set 24 inches in ground with standard signs 54-2 and 54-4 attached due North 3.6 feet

All reference bearings are true bearings.
