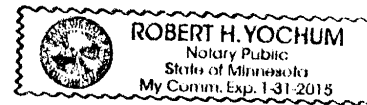

, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 20th day of February, 1963, I found the Angle point 1 corner of section 3 which was evidenced by the remains of the GLO survey of 1917.

Corner was found to be marked by a 1 inch diameter iron post with a brass cap stamped:-

1917

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as the G.L.O. brass cap is in good condition.
