

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Benidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 5th day of August, 1968, I found the East 1/16 corner of Sections 3-10 which was evidenced by remains of the G.L.O. resurvey of 1917 consisting of 1 inch diameter iron post 3 feet long with brass cap marked E 1/16 S3
R. Oak 1 1/4 inch S30 1/2° E 83.16 feet - not found S10
N. Pine 1 1/4 inch N80 1/4° W 103.62 feet - not found 1919

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6 inch diameter cylindrical concrete monument 5 feet long capped with a 3 inch diameter bronze tablet stamped
