

WILLIAM H. OKERMAN, being first duly sworn, deposes and says:
 That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 16th day of April, 1964, I found the Northwest 1/16 corner of Section 12 which was evidenced by remains of the G. L. O. resurvey of 1917. Brass Cap found in place.

R. Oak 12" S10 $\frac{1}{2}$ °E 79.20' (now a 23" oak at record bearing and distance.)
 R. Oak 14" S31°W 143.88' (now a 20" oak at record bearing and distance.)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as the G. L. O. Brass Cap is in good condition.
