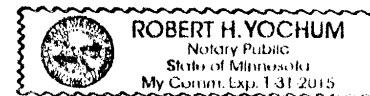

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 29th day of July, 1968, I found the Center Quarter corner of Section 10 which was evidenced by remains of G.L.O. resurvey of 1917 consisting of 1 inch diameter iron post 3 feet long with brass cap marked C $\frac{1}{4}$ S10
J. Pine 10 inch S85°E 55.44 feet - not found 1917
N. Pine 12 inch N53°W 63.36 feet - not found

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as G.L.O. monument is in good condition
