

William H. Okerman , being first duly sworn, deposes and says:

That I reside at Bemidji , Minnesota , and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.....

I further depose and say that on the 29th day of July , 19 68, I found the Center East 1/16 corner of Section 10 which was evidenced by remains of the G.L.O. resurvey in 1917 consisting of 1 inch diameter iron post 3 feet long with brass cap marked

C E 1/16 C
S10
1917J. Pine 12 inch N39°E 11.22 feet - not found
J. Pine 16 inch S20°W 11.22 feet - not found

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as G.L.O. monument is in good condition.....


