

 That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.  
 I further depose and say that on the 30th day of July, 1963, I found the Center West 1/16 corner of Section 12 which was evidenced by remains of the G. L. O. resurvey of 1917. Brass Cap found in place.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as G. L. O. Brass Cap is in good condition.
