









## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Center Quarter

Corner to Sec. 12 T. 111N R. 30W No. 95

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 25th day of September, 1962, I found the Center Quarter corner of Section 12 which was evidenced by two bearing trees from the G.L.O. Survey of 1917.

Red Oak 6" N35°E 58 Lks. or 38.28 feet (Now a oak clump and decayed stump N35°E 38.28 feet)

Red Oak 5" S 3¼°E 29 Lks. or 19.14 feet (Now stump hole S3¼°E 19.14 feet.)

Corner was found to be marked by a 1" diameter iron pipe with brass cap stamped:-

C. S12 set by General Land Office.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new monument set as G.L.O. brass cap is in good condition.

from which reference or witness monuments are located in the manner following:

Oak 12" N46½°E 32.7 feet Marked C. S12 RT

Oak 13" S59°W 46.0 feet Marked RT

Steel sign post 72" long, set 24" in ground with signs 54-2 and 54-4 attached N88°W 4.3 feet.

All reference bearings are true bearings.
