

AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

North East 1/16

Peter J. Meyer, being first duly sworn, deposes and says:
 That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.
 I further depose and say that on the 16th day of April, 1962, I found the North East 1/16 corner of Section 15 which was evidenced by the remains of the G.L.O. resurvey of 1917. Corner was found to be marked by a 1 inch diameter iron post with a brass cap stamped:

Poplar 10 inch S39 $\frac{1}{2}$ °E 76 links (50.16') (now a 13 inch aspen
 S39 $\frac{1}{2}$ °E 50.16 feet with scribe visible)

NE 1/16 S 15
 1917

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as the G.L.O. brass cap is in good condition.

from which reference or witness monuments are located in the manner following:

Oak 8 inch S7°E 21.0 feet Marked NE 1/16 BT

Oak 10 inch N76 $\frac{1}{2}$ °W 32.6 feet Marked NE 1/16 BT

Steel sign post 72 inches long, set 24 inches in ground with standard signs 54-2 and 54-4 attached due West 5.15 feet.

All reference bearings are true bearings.
