



William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 13th day of August, 1968, I found the North West 1/16 corner of Section 14 which was evidenced by remains of the G.L.O. resurvey of 1917 consisting of 1 inch diameter iron post 3 feet long with brass cap marked. NW 1/16 S14 1917

Poplar 7 inch N41-3/4°E 21.12 feet - not found
Poplar 8 inch S46°W 7.92 feet - not found

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as G.L.O. monument is in good condition.
