

## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 19th day of April, 1962, I found the Quarter corner of sections 14 - 15 which was evidenced by the remains of the G.L.O. survey of 1917.

Corner was found to be marked by a 1 inch diameter iron post with a brass cap stamped:-

Poplar 6 inch N67 $\frac{1}{4}$ °E 49 links (32.34') (now an aspen stump at record bearing and distance). S 15 $\frac{1}{4}$  S 14 1917  
 Poplar 12 inch N39 $\frac{1}{4}$ °W 164 links (108.24') (now a 17 inch aspen N39 $\frac{1}{4}$ °W 106.0 feet with scar facing corner).

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as the G.L.O. brass cap is in good condition.

from which reference or witness monuments are located in the manner following:

Tamarack 15 inch S60 $\frac{1}{2}$ °E 88.9 feet marked 1/4 S 14 BT

White pine 8 inch S68°W 80.6 feet marked 1/4 S 15 BT

Oak 8 inch N18°W 61.0 feet marked 1/4 S 15 BT

Steel sign post 72 inches long, set 24 inches in ground with standard signs 54-2 and 54-4 attached due North 3.45 feet.

All reference bearings are true bearings.
