

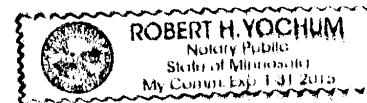

## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Closing corner on south boundary of Indian Reservation West 1/16 line of  
Corner to Sec. 17 T. 141 N. R. 30 W. No.State of Minnesota, }  
County of Cass } ss.

, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 19th day of February, 1963, I found the closing corner of the west 1/16 line section 17 I.R.B. which was evidenced by the remains of the G.L.O. survey of 1917.

corner was found to be marked by a 1 inch diameter iron post with a brass cap stamped:

Norway pine 8 inch S 6 1/2° E 25 1/4 links (167.64') (now a 12" stub with scribe plain, at record bearing and distance).

Jack pine 4 inch N 80 1/4° W 148 links (97.68') (now a 13" Jack pine at record bearing and distance with scribe visible)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as the G.L.O. brass cap is in good condition.
