That I reside at Bemidji , Minnesota , and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807

I further depose and say that on the 5th day of October , 19 64, I found the Quarter corner of sections 19 - 30
which was evidenced by remains of Cass County survey, notes are on record in the Cass County courthouse.

Found a 2 inch diameter iron pipe at fence corner.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2inch inside diameter 5 feet long galvanized wrought iron pipe filled with concrete and capped with a 3 inch diameter bronze tablet stamped.
