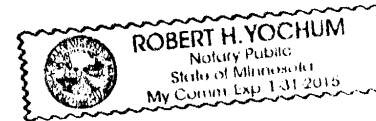

## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Corner to Sec. 30 T. 141N R. 30W No. 629

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 5th day of October, 1964, I found the CN 1/16 corner of Section 30 which was evidenced by a 2 inch diameter monument. Notes are on record in the Cass County Courthouse.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2 inch inside diameter 5 feet long galvanized monument filled with concrete and capped with a 3 inch diameter bronze tablet stamped:

T141N, R30W  
CN 1/16 S30  
1965  
R.L.S. No. 6807

from which reference or witness monuments are located in the manner following:

Oak 8 inch N47°W 14.1 feet scribed CN 1/16 BT.  
Oak 9 inch N58°E 39.9 feet scribed CN 1/16 BT.  
Oak 11 inch N34°E 46.3 feet scribed CN 1/16 BT.

Steel Sign post 72 inches long set 24 inches in ground with Forest Service signs 54-2 and 54-4 attached due West 7.9 feet.

All reference bearings are true bearings.
