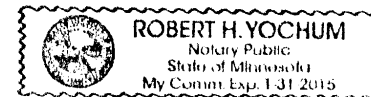

 That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.  
 I further depose and say that on the 22nd day of September, 1964, I found the Section corner of Sections 25-26-35-36 which was evidenced by a 2 inch diameter iron pipe capped at corner location.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6 inch diameter 5 feet long cylindrical concrete monument capped with a 3 inch diameter bronze tablet stamped.
