

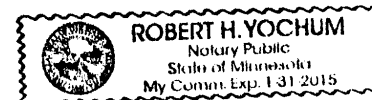

AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Corner to Sec.'s 32 - 33 T. 141N R. 30W No. 542

William H. Okerman, being first duly sworn, deposes and says:

That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 28th day of May, 1965, I found the Standard corner of Section's 32 - 33 which was evidenced by remains of original Government survey of 1873.

Y. Pine 8 inch N14°W 8.58 feet - now a badly burned pine stump with BT visible N12°W 9.0 feet.

Y. Pine 6 inch N69°E 8.58 feet - now a badly burned pine stump with scribe mark visible N69°E 8.58 feet.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2 inch inside diameter 5 feet long galvanized steel monument filled with concrete and capped with a 3 inch diameter tablet stamped:

S5
T140N
1965
R.L.S. No. 6807

from which reference or witness monuments are located in the manner following:

Oak 8 inch N3°E 49.0 feet scribed S33 BT.
N. Pine 15 inch N62°E 80.1 feet scribed S33 BT.

Steel sign post 72 inches long set 24 inches in ground with Forest Service signs 54-4 and 1505 attached due West 4.1 feet.

All reference bearings are true bearings.
