

 That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 25th day of July, 1962,
 I found the Section corner of 5-6-31-32
 which was evidenced by remains of a survey by Cass County Surveyor John Curo in 1916.
 Cass County record Book "C", page 113.

Iron monument (found tipped over in old trail alongside corner)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter 5' long, galvanized wrought iron pipe filled with concrete and capped with a 3" diameter bronze tablet stamped:
