That in such capacity Affiant has knowledge of the books and records kept in the Office of the County Surveyor in and for the County of Cass, State of Minnesota;

That the attached CERTIFICATE OF LOCATION OF GOVERNMENT CORNER has been found in the Surveyor's records and after checking with the Cass County Recorder, it was determined that the document was never assigned a document number and was never officially recorded in the real estate records or tracted in the tract indexes within said Cass County Recorder's Office;

AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Peter J. Meyer , being first duly sworn, deposes and says:

That I reside at Cass Lake Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 28th day of June ,19 62,

I found the West 1/16 corner of Sections 5 - 32

which was evidenced by a 2" diameter iron pipe set by Cass County Surveyor John M. Greene in 1925. A plat of his survey is filed in Cass County Courthouse. This pipe was found alongside a East-West fence line.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2 inch inside diameter, 5 foot long galvanized wrought iron pipe filled with concrete and capped with a 3 inch diameter bronze tablet stamped:—Tlh2N R31W

W 1/16 $\frac{5}{5}\frac{32}{5}$ 1962 R.L.S. No. 3628

from which reference or witness monuments are located in the manner following:

Oak 6" N56°E 6.3' MKD W 1/16 S 32 BT

Oak 10" S18°W 17.85' MKD W 1/16 S5 BT

Granite boulder 7.0 feet x 6.0 feet x 1.3 feet above ground N73°W, 30.1 feet to an "X" mark on top at North-East corner.

Steel sign post 72 inches long set 24 inches in ground S760W, 3.4 feet.

All reference bearings are true bearings.
