That I reside at Cass Lake , Minnesota , and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 28th day of June , 19 62 , I found the Quarter corner of Sections 5 - 32

which was evidenced by Notes of Cass County Surveyor John Curo in 1916, found in record book C, page 113, in Cass County Courthouse.

Iron monument 2" x 48" (found marking corner approximately 6 feet East of fence line.)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter, 5' long galvanized wrought iron pipe filled with concrete and capped with a 3" diameter bronze tablet stamped:
