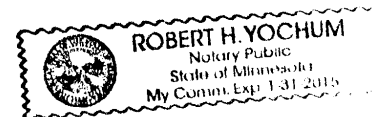

, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 27th day of June, 1962, I found the Section corner of Sections 4-5-32-33 which was evidenced by notes of Cass County Surveyor John Curo in 1916, taken from Cass County record book "C" page 113.

Iron monument 2" x 48" (found in place marking corner beside an old fence line).

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter, 5' long galvanized wrought iron pipe filled with concrete and capped with a 3" diameter bronze tablet stamped:-
