

AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 27th day of June, 1962, I found the West 1/16 corner of Sections 4 - 33 which was evidenced by a 2" diameter capped iron pipe set by Cass County Surveyor John M. Greene in 1924. A plat of his survey is filed in Cass County Courthouse. This pipe was found alongside a fence line. A Forest Service metal location post dated 1937 was found on a fallen aspen tree North-West of corner.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2 inch inside diameter, 5 foot long galvanized wrought iron pipe filled with concrete and capped with a 3 inch diameter bronze tablet stamped:-

from which reference or witness monuments are located in the manner following:
