That I reside at Cass Lake , Minnesota , and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 12th day of April , 19 62, I found the South 1/16 corner of Sections 3 - 4

which was evidenced by a plat of Cass County Surveyor John M. Green in 1924

Iron monument (found a 12 inside diameter iron pipe marking corner)

Corner is at intersection of old E-W & N-S survey line. This location checks with map and aerial photo.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2 inch inside diameter 5 foot long galvanized wrought iron pipe filled with concrete and capped with a 3 inch diameter bronze tablet stamped:-
