

AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Peter J. Meyer, being first duly sworn, deposes and says:
 That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.
 I further depose and say that on the 21st day of May, 1962, I found the East 1/16 corner of Sections 4 - 9 which was evidenced by a 2" inside diameter capped iron pipe set by John M. Greene in 1924. A plat of his survey is filed in the Cass County courthouse.

This corner is alongside an old fence corner.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter, 5' long galvanized wrought iron pipe filled with concrete and capped with a 3" diameter bronze tablet stamped:-
