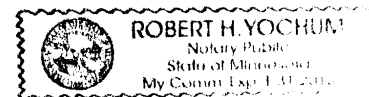

AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 14th day of May, 1962, I found the Quarter corner of Sections 1 - 12 which was evidenced by remains of the G.L.O. resurvey of 1917

An iron post 1" diameter with a brass cap marked $\frac{1}{4}$ S 1 (Found in place)
White oak 6" N61½°W 55 links (36.30') (Not found) S 12 1917
White Oak 8" S72½°W 75 links (49.50') (Now a 17" oak S72½°W 49.50' scribe overgrown)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as G.L.O. brass cap is in place.

from which reference or witness monuments are located in the manner following:

to perpetuate this corner I marked new bearing trees.

Oak 12" N12°E 21.0' marked $\frac{1}{4}$ S 1 BT

Oak 6" S 46°E 43.5' marked $\frac{1}{4}$ S 12 BT

Steel sign post 72" long with signs 54-2 and 54-4 attached East 2.8'
