

AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 17th day of May, 1962, I found the Northwest 1/16 corner of Section 7 which was evidenced by a 2" inside diameter capped iron pipe set by Cass County Surveyor John Curo in 1915, a plat of his survey is filed in Cass County Courthouse. This pipe is alongside an old fence corner.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6" diameter 5' long cylindrical concrete monument capped with a 3" diameter bronze tablet stamped:-

T141N R31W
 NW 1/16 S 7
 1962
 R.L.S. No. 3628

from which reference or witness monuments are located in the manner following:

Oak 6" S43°W 16.55' MKD NW 1/16 BT

Oak 8" N75°W 22.95' MKD NW 1/16 BT

Set a steel sign post 72" long South 2.35 feet

All reference bearings are true bearings.
