

AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 26th day of June, 1962, I found the North East 1/16 corner of Section 7 which was evidenced by remains of a survey by Cass County Surveyor John Curo, in 1915. A plat of his survey is filed in Cass County Courthouse.

Iron monument (found a 2" inside diameter iron pipe marking corner alongside a fence corner. Found a 2" inside diameter iron pipe marking corner alongside a fence corner. Found 2 Forest Service metal location posters on an Elm tree N-W of corner. One tag dated 1946, other is older and not readable)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter, 5' long galvanized wrought iron pipe filled with concrete and capped with a 3" diameter bronze tablet stamped:-

from which reference or witness monuments are located in the manner following:

All reference bearings are true bearings.
