

, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 22nd day of May, 1962, I found the Center West 1/16 corner of Section 7 which was evidenced by a 2" inside diameter capped iron pipe set by Cass County Surveyor John Curo in 1915. This pipe was found beneath the surface of a road and in line with a North-South fence estimated to be 30 years old.

An F. S. metal location poster on a cedar post north side of road gave bearing and distance to corner.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6" diameter, 24" long cylindrical concrete monument capped with a 3" diameter bronze tablet stamped:-

Note: Monument is buried 7" under road surface

from which reference or witness monuments are located in the manner following:
