

, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 23rd day of April, 1962, I found the South 1/16 corner of Sections 11 - 12 which was evidenced by G.L.O. survey of 1917.

Iron post 3 foot long, 1 inch diameter with brass cap marked:- S 1/16  
 Cedar 10" S69°E 207 links (136.62') (Now a cedar stump badly burned S69°E 136.62') S 11 | S 12  
 1917  
 Cedar 10" S12-3/4°W 281 links (185.46') (Now a cedar stump badly decayed S13°W 185.46')

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new marker set as G.L.O. brass cap is in place.
