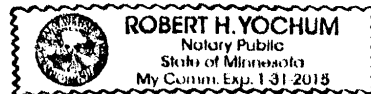

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 5th day of April, 1962, I found the South West 1/16 corner of Section 12 which was evidenced by the G.L.O. survey of 1917

1. Iron post 3 foot long, 1 inch diameter with a brass cap marked: SW 1/16 S12 (Found in 1917 place)
2. W. Pine 18" S56 1/2° E 152 links (100.32') (Now a 25" red pine S57° E 100.4' with blaze facing corner.)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of No new monument set as G.L.O. brass cap is in place.

from which reference or witness monuments are located in the manner following:
