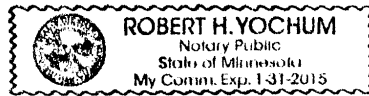

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 25th day of September, 1962, I found the South 1/16 corner of Sections 7 - 12 which was evidenced by G.I.C. brass cap marked: S 1/16 bent over under surface of road.
