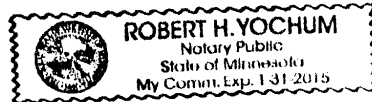

AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Peter J. Meyer, being first duly sworn, deposes and says:
 That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.
 I further depose and say that on the 16th day of April, 1962, I found the Quarter corner of Sections 10-15 which was evidenced by the remains of the G.L.O. resurvey of 1917. Corner was found to be marked by a 1 inch diameter iron post with a brass cap stamped:
 Poplar 10" N14¼°E 26 links (17.16') (now a decayed stump at record bearing and distance) $\frac{1}{4} \frac{S 10}{S 15}$ 1917
 Poplar 8" S58-¾°E 9 links (5.94') (now a decayed stump at record bearing and distance).

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as the G.L.O. brass cap is in good condition.

from which reference or witness monuments are located in the manner following:

White pine 15 inch S6°W 68.0 feet MKD 1/4 S 15 BT
 Steel sign post 72 inches long, set 24 inches in ground with standard signs 54-2 and 54-4 attached due West 4.4 feet.

All reference bearings are true bearings.
