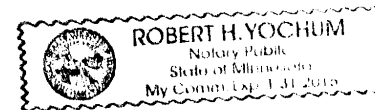

## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Corner to Sec.'s 8-9-16-17 T. 111 N R. 31 W No.

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 1st day of May, 1962, I found the Section corner of Sections 8-9-16-17

which was evidenced by a 2 inch x 1/8 inch iron pipe set by Cass County Surveyor E. P. Horst in 1917 from the four original Government BT's.

Remains of one County BT -

Birch 5" S55°20'E 50.0' (now a birch stump in a clump of small birch S55°10'E 50.0')

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter 5 foot long galvanized wrought iron pipe filled with concrete and capped with a 3 inch diameter bronze tablet stamped:-

Cedar post 4" x 4" x 72" penta-treated with red top S55°W 1.87'
