

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 24th day of April, 1962, I found the I.R.B. corner of Section 13 which was evidenced by remains of G.L.O. survey of 1917.

1. Iron post 3 feet long, 1 inch diameter with brass cap marked (Found in place alongside old fence line est. 30 years)
2. Mound of stone North of corner (found a mound of stone adjacent to and on North side of corner.)
