

## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

North 1/16

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 13th day of September, 1962, I found the North 1/16 corner of Sections 13 - 18 which was evidenced by one oak bearing tree from the G.L.C. resurvey of 1917.

Oak 5 inch N50°E 103 links or 67.98 feet (now a 13 inch oak at record bearing and distance-chopped in and scribe "1/16" was visible.) Found brass capped corner monument pulled up and laying alongside of road.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6 inch diameter, 24 inch long, cylindrical concrete monument capped with a 3 inch diameter bronze tablet stamped:-
