

AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

, being first duly sworn, deposes and says:

That I reside at Cass Lake Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 10th day of July, 1962, I found the Section corner of Sections 17-18-19-20 which was evidenced by remains of two pine bearing trees from the original government survey

of 1873.

W. Pine 8" North 80 Lks or 52.8' (Now some pine roots under bog North 52.8')

N. Pine 20" S 27°W 230 Lks or 151.8' (Now a pine stp. & windfall badly burned S 27°W 151.8')

Corner was found to be marked by a 2" diameter iron pipe set by Cass County Surveyor John Curo in 1915.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter 5' Long galvanized wrought iron pipe filled with concrete

and capped with a 3" diameter bronze tablet stamped: -

from which reference or witness monuments are located in the manner following:
