



AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Corner to Sec. 's 15-16-21-22 T. 141 N R. 31 W No.

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 29th day of August, 1962, I found the Section corner of Sections 15-16-21-22 which was evidenced by the stumps of three pine bearing trees from the original Government survey of 1873.

Yellow pine 8" N72°E, 52 links or 34.32' (Now a 12" pine stub N72°E, 34.32')
Yellow pine 14" N14°W, 84 links or 55.44' (Now a pine stump badly burned N14°W, 54.44')
Yellow pine 10" S53°E, 22 links or 14.52' (Now a pine stump badly burned S53°E, 14.52')

Found some badly burned wood in hole at point for corner.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter 5' long galvanized wrought iron pipe filled with concrete and capped with a 3" diameter bronze tablet stamped:-
