

## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 8th day of June, 1962, I found the North East 1/16 corner of Section 30 which was evidenced by a 1½" inside diameter iron pipe set by Cass County Surveyor E. B. Horst in 1921. Notes of this survey found in County Record Book "C", page 447, Cass County Courthouse.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6" diameter 5' long cylindrical concrete monument capped with a 3" diameter bronze tablet stamped:-

 RLS No. 3628

from which reference or witness monuments are located in the manner following:
