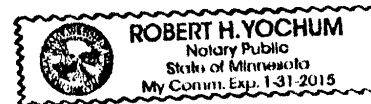

## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

Peter J. Meyer, being first duly sworn, deposes and says:  
 That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.  
 I further depose and say that on the 25th day of June, 1962, I found the North 1/16 corner of Sections 26 - 27 which was evidenced by Notes of Cass County Surveyor E. B. Horst in 1920 - taken from Cass County Record Book "C" Page 462.

Iron monument (found a 2" inside diameter iron pipe marking corner under a downed fence line estimated to be 30 years old).

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter, 5 foot long galvanized wrought iron pipe filled with concrete and capped with a 3" diameter bronze tablet stamped:-
