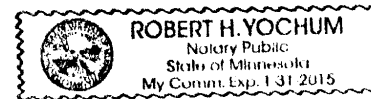

AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

South East 1/16

Corner to Sec. 26 T. 141N R. 31 W No. 177

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 17th day of May, 1962, I found the South East 1/16 corner of Section 26 which was evidenced by a 2 inch outside diameter iron pipe set by Cass County Surveyor E. B. Horst in 1920. A plat of his survey is on file in the Cass County Courthouse. Corner is at intersection of old cut out survey lines N-S and E-W

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6" diameter 5 foot long cylindrical concrete monument capped with a 3" diameter bronze tablet stamped:- T141N R31W

from which reference or witness monuments are located in the manner following:

Red Pine 22" S41°E 40.7' marked SE 1/16 BT

Oak 8" S67°W 15.2' marked SE 1/16 BT
