

Peter J. Meyer, being first duly sworn, deposes and says:
 That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.
 I further depose and say that on the 25th day of June, 1962, I found the South East 1/16 corner of Section 25 which was evidenced by a survey of Cass County Surveyor E. B. Horst in 1920. Notes taken from Record Book "C", Page 461 Cass County Courthouse.

Iron monument 2" x 48" (Found 2" x 48" iron pipe marking corner alongside a fence line).

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6" diameter, 5 foot long cylindrical concrete monument capped with a 3" diameter bronze tablet stamped:
