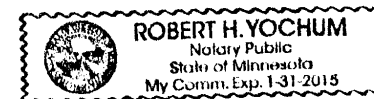

which reference or witness monuments are located in the manner following:

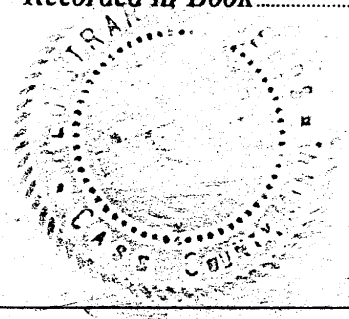
- a 4x4x100 inch cedar post bears N 45°13' E 19.30 ft Mkd S.30 T.141 R.31
