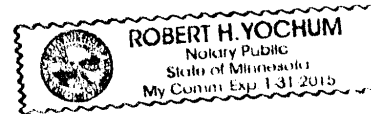

which reference or witness monuments are located in the manner following:

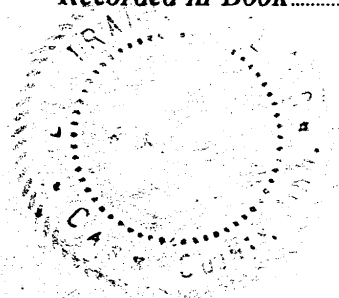
- Ash tree 7 inches in diam bears N 69°30' E 46.65 ft Mkd S. 30 T. 141 R. 31
