

Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 25th day of April, 1962, I found the M.C. and W.C. corner of Sections 26 - 35 which was evidenced by an iron pipe set by Cass County Surveyor E. B. Horst in 1920 recorded in County record book C, page 462.

Location checks with type map and aerial photos.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6 inch diameter, 5 foot long cylindrical concrete monument capped with a 3 inch diameter bronze tablet stamped:-
