

, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 24th day of May, 1962, I found the Quarter corner of Sections 31-32 which was evidenced by on iron pipe set by Cass County Surveyor E. B. Horst in 1921

Notes of survey found in Cass County Record Book "C" page 446.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 2" inside diameter 5 foot long galvanized wrought iron pipe filled with

concrete and capped with a 3" diameter bronze tablet stamped: -
