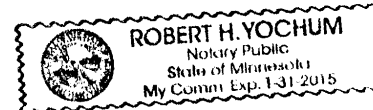

Peter J. Meyer, being first duly sworn, deposes and says:
 That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628
 I further depose and say that on the 24th day of April, 1962, I found the Center Quarter corner of Section 34 which was evidenced by a plat of Cass County surveyor John M. Green in 1928 Iron monument (found a 1 1/2" inside diameter iron pipe marking corner.)
 Corner location checks with timber type map and aerial photos.

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of a 6 inch diameter 5 foot long cylindrical concrete monument capped with a 3 inch diameter bronze tablet stamped:-
