That I reside at Bemidji, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 6807.

I further depose and say that on the 5th day of September, 1969, I found the Section corner of Sections, 7, 18, 12, 13 which was evidenced by remains of the G.L.O. resurvey of 1918 consisting of 2 inch diameter iron post 3 feet long with brass cap marked
