





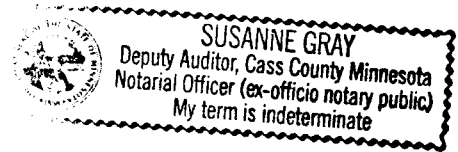

## AFFIDAVIT AS TO LOCATION OF GOVERNMENT CORNER

, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 7th day of March, 1963, I found the South 1/16 corner of Sections 22 - 23 which was evidenced by the remains of the G.L.O. resurvey of 1926. Corner was found to be marked by a 1 inch diameter iron post with a brass cap stamped:-

Balsam 5" S61°30'E, 29 links (19.14')(now a decayed stump  
 S62°E 19.14 feet)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as the G.L.O. brass cap is in good condition.
