 That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 8th day of March, 1963,
 I found the southwest 1/16 corner of section 23
 which was evidenced by the remains of the G.L.O. survey of 1926.
 Corner was found to be marked by a 1 inch diameter iron post with a brass cap stamped:-

SW 1/16 S 23
 1926

Cedar 12" S9°W 32 links (21.12')(Now a 13" cedar S12½°W 21.12 feet
 scribed "SW 1/16 S 23 BT")

Cedar 16" N79½°W 31 links (20.46')(Now a 17" cedar stump N75°W 20.46 feet with scribe
