That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628

I further depose and say that on the 23rd day of May, 1963,

I found the Quarter corner of Sections 19 - 30 which was evidenced by the remains of the GLO resurvey of 1926

Iron post 1 inch diameter with a brass cap stamped:- $\frac{1}{4}$ S19
 $\frac{1}{4}$ S30

Elm 10 inch N47°E 31 links (20.46 feet) (Now a wind-fall at record bearing and distance with scribe "1/4 S19 BT" visible.)

Elm 14 inch S84°E 12 links (7.92 feet.) (Now a 18 inch Elm at record bearing and distance with scribe "1/4" visible.)

and that to perpetuate the location of such corner I did, at the exact location thereof, place a permanent marker consisting of no new monument set as the GLO brass cap is in good condition.
