Peter J. Meyer, being first duly sworn, deposes and says:

That I reside at Cass Lake, Minnesota, and am registered as a Land Surveyor under the laws of the State of Minnesota, having Surveyor's Registration Certificate No. 3628.

I further depose and say that on the 23rd day of May, 1963, I found the East 1/16 corner of Sections 19 - 30 which was evidenced by the remains of the GLO resurvey of 1926.

Iron post 1 inch diameter with brass cap stamped:-

Elm 1 1/2 inch S10°W 3 links or 1.98 feet (Now a Elm stub S10°W 1.98 feet with scribe overgrown.)
